#### **Business Centre Terms and Conditions for invited importers:**

- 1.- Opening times: 5 to 7 May, from 10:00 to 19:00.
- 2.- Attend FENAVIN for at least two days, staying for at least 5 hours each day. Visits to wineries only after 19.00h.
- 3.- The Organisers will implement attendance controls and if necessary, the Organisers will impose appropriate penalties.
- 4.- Confirm a minimum of 10 meetings using the restricted area on the website. These meetings can be requested by the visitors or by the exhibitors.
- 5.- Register on arrival at the Business Centre, Pavilion Eneo -1-. This is in addition to the barcode reading at the main gates.
- 6.- At the end of your visit to FENAVIN, submit the completed evaluation form for the fair to the Business Centre.
- 7.- **CANCELLATION FEES:** If the invited company cancels its participation once the Organisers have incurred expenses of travel tickets or hotel booking, the invited company undertakes to cover 100% of the cancellation fees.
